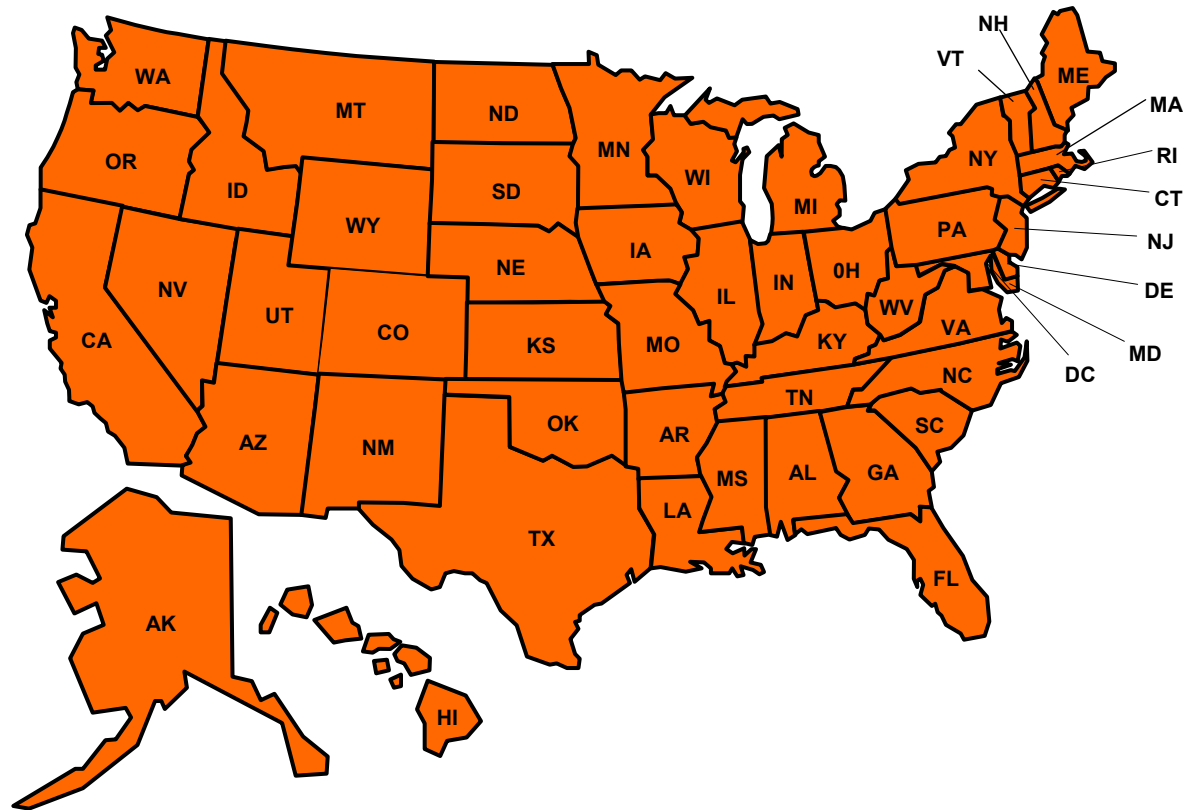

² Or a co-payment of \$2.50 for generic (including brand drugs treated as generic) and \$6.30 for all other drugs if co-payment is higher than 5% of cost.
